## President's Perch

Hi Everyone – It looks like Autumn is upon us with all its glory! It's hard to stay inside these days. The Slate-colored Juncos are back (snow birds to some), to remind us that winter is on its way...

This newsletter contains a lot of information on "Take Back Audubon" (TBA). It sounds a bit aggressive, and it is meant to be. We, the grass roots of National Audubon Society (NAS), want Chapters (PVAS is a Chapter) to remain a focal point in the NAS organization. The move to focus on Audubon Centers and State Offices is taking members, dollars, and support away from Chapters, and Chapters are suffering as a result.

I don't think PVAS would exist today if it were not for the support that we received from our (now closed) Regional Office in nearby Harrisburg, PA. As the years have gone by we, the Chapters of Audubon, have seen a steady decline in services and support from NAS. The latest is the readjustment of the "net dues share" (now revised and called the "security net"). PVAS was receiving \$5.50 "net dues share" for every membership that PVAS generated. This year we received approximately \$1 for PVAS generated members, and this may be the last year we receive any money at all. With approximately 600 members, many of which were generated by PVAS, this is a real budget cut! NAS advertises that with your subscription to the magazine you get a "free" membership in your local Chapter (it isn't free to us! We pay to give service to our members, like this newsletter you're reading!)

I have been an Audubon member for many years and I hate to see NAS moving away from being a grass-roots inspired organization. I would like to see that change reversed. At the



October board meeting, your PVAS Board, agreed that the idea behind TBA is a good one, and voted to support it. The way we can put some muscle in that vote is by asking each of you to fill out, sign, stamp and send the Proxy that we have inserted in this issue of Valley Views.

## Arctic National Wildlife Refuge Threatened with Oil and Gas Drilling...Again

The Arctic National Wildlife Refuge (ANWR) is often referred to as America's "Serengeti." This incomparable wilderness is habitat to more than 250 animal species, including polar bears, wolves, grizzlies, caribou and millions of migrating birds. The migrating birds that inhabit ANWR include the Tundra Swan, Lesser Scaup (inset), Spotted Sandpiper, Semipalmated Sandpiper, Stilt Sandpiper and Common Redpoll that over-winter or migrate through West Virginia to breed on the coastal plain. But this is not important to oil people.



**They're at it again!** Audubon Advisory reminds us that special interests and their allies in Washington are pulling out all the stops to get their hands on Alaska's wilderness. They are trying to win over key members of the U.S. Senate by loading up the "energy bill" with measures that would benefit their states. This includes proposals to increase the use of corn-based ethanol in the nation's gasoline supply, and boost energy assistance to low-income families for heating and cooling. These are important issues that deserve to be addressed and *passed on their own merits*, not used as lures or bait in exchange for opening ANWR to oil and gas drilling.

The Wilderness Society reports that "the amount of oil that the U.S. Geological Survey estimates could be recovered from the Arctic Refuge would amount to *less than a six-month supply* for American consumers. In two early reports, the U.S. Department of Interior stated the odds for *economically recoverable* oil in ANWR was between 20% and 43%, tops...not even 50%!

According to the Congressional Research Service report to Congress, we export crude oil to North Korea, Japan and China. If we have an energy security issue, as this administration wants us to believe, why are we *exporting* our precious Alaska oil to other countries? According to the Congressional Research Service report to Congress, we export crude oil to North Korea, Japan and China. The energy security argument is not based on honest facts.

**There are other solutions!** Did you know that if only 27% of cars in 2000 were the 48-49-mpg hybrid electric models, or 15% were ultra-light hybrid SUVs, they could displace *all* Gulf oil imports? *Already-designed*, un-compromised, cost-competitive, quintupled-efficiency cars that use no oil but only hydrogen fuel cells, if used worldwide, could displace *all* of OPEC's output. Why aren't we doing this? Think about it!

As currently written, the so-called "energy bill" does not call for an increase in the fuel efficiency of cars and trucks. It *rolls back* existing environmental safeguards for oil and gas

drilling on public lands. It does not include measures to diversify America's energy supplies, nor does it address meaningful ways to reduce global warming. Allowing drilling in ANWR would also make it easier to drill in other sensitive places.

**Keep the pressure on!** West Virginia's Senator Byrd (202-224-3954) is among the 16 senators being targeted for "luring" their votes to end the filibuster that would send the bill back to the drawing board! This isn't an "either-or situation" – our lawmakers do not have to trade away the Arctic National Wildlife Refuge in order to bring jobs back home, or supply Americans with clean, affordable and reliable energy.

Call, write, and/or visit your Senators and *tell your friends in the states listed below to contact their lawmakers to voice support for a filibuster*, and send the measure back to the drawing table. Tell them to encourage their colleagues to oppose efforts to open the Arctic National Wildlife Refuge to oil and gas drilling! The 16 senators that need to hear from their constituents are: Arizona's John McCain; Arkansas' Mark Pryor and Blanche Lincoln; Illinois' Peter Fitzgerald; Indiana's Evan Bayh and Richard Lugar; Maine's Susan Collins; Minnesota's Norm Coleman; Nebraska's Ben Nelson; North Dakota's Kent Conrad and Byron Dorgan; Ohio's Mike DeWine; Oregon's Gordon Smith; Pennsylvania's Arlen Specter; Vermont's Patrick Leahy; and *West Virginia's Robert Byrd* (202-224-3954).

## TAKE BACK AUDUBON GROUP SEEKS PROXIES

As many Auduboners are aware, the National Audubon Society has made changes in its relationship with local Chapters that have significantly impacted Chapter finances, and the role of the Audubon grassroots in our organization.

In 2000, the NAS Board of Directors changed the long-standing policy of sharing membership dues with Chapters. Under the new policy that will be fully implemented next year, the dues share will drop to near zero for most Chapters. This loss of revenue has forced Chapters to cut back on newsletters and to reduce their conservation and education activities—the most effective activism in all of Audubon. In addition, NAS has started to omit all references to chapters in public relations material. Instead, the Audubon Centers and State Offices are stressed. In West Virginia, as in about 25 other states, there is no State Office, nor Audubon Center.

In response to these “anti-chapter” actions by NAS, a grassroots organization, ‘Take Back Audubon’ (TBA) has sprung up, whose mission is “to restore a true partnership between the independent Chapters and the National Audubon Society through a real voice in the NAS organization and in all decisions that affect Chapters”. To date, 41 Audubon Chapters and over 120 Chapter leaders have endorsed Take Back Audubon, (including PVAS).

Presently, TBA is engaged in an effort to elect an alternate slate of candidates to the NAS Board of Directors at this year’s Annual Meeting on Dec. 6, 2003. They are seeking proxies from Audubon members to bring to the meeting to vote for this slate, and to support resolutions that will be presented to democratize Audubon and to restore the Chapter dues share.

Eight TBA candidates have declared their candidacy for directors-at-large. They are: Chuck Bragg, Santa Monica Bay Audubon (CA), Marsha Cannon, Madison Audubon (WI); John Gallagher, Clark County Audubon (OH); Andrew Mason, Delaware-Otsego Audubon (NY); Cary Meister, Yuma Audubon (AZ); Pat Rasmussen, Leavenworth Audubon Adopt-a-Forest (WA); Darrel Whipple, Willapa Hills (WA/OR); and Jennifer Wilson-Pines, North Shore Audubon (NY).
